**A. AGENDA ITEMS REQUIRING FORMAL ACTION**

1. Consider approval of the public and executive session minutes of the September 16, 2020 Commission meeting.
2. Consider ratification of the approval of the modified wagering format at New Meadowlands Racetrack beginning November 6, 2020.
3. Consider ratification of the approval granted to Monmouth Park to cancel live racing on October 12, 2020 due to heavy rains and high winds.
4. Consider the grant of 2021 standardbred permits to conduct racing at New Meadowlands Racetrack and Freehold Raceway; the grant of 2021 thoroughbred permits to conduct racing at Monmouth Park and the Meadowlands (including the special steeplechase permit for racing at Moorland Farm); and the allocation of race dates to the permit holders.
5. Consider approval of Freehold Raceway's officials, pools, post-time, prices and wagering format for the 2021 winter/spring meet.
6. Consider approval of New Meadowlands Racetrack's officials, pools, post-time, prices and wagering format for the 2021 standardbred meet.
7. Consider the renewal of licenses for 2021 for the off-track wagering facilities ("OTWs") located in Toms River, Woodbridge, Bayonne, Gloucester Township, Hillsborough and Egg Harbor Township.
8. Consider the renewal of the account wagering license for 2021.
9. Consider approval of the New Jersey permit holders' requests to conduct sending and receiving, intra and interstate simulcasting with racetracks, OTWs and the account wagering system in 2021 and to conduct common pool and separate pool parimutuel wagering thereupon.
10. Consider approval of the request of the Borgata Hotel, Casino and Spa ("Borgata") to accept intra and interstate simulcasting from approved racetracks and to conduct intra and interstate common pool and separate pool parimutuel wagering in 2021.

11. Consider approval of Sportech Racing, Inc. to continue to provide totalisator services and act as the hub facility at the Mount Laurel Data Center in 2021 for racetracks, the OTWs, the Borgata and the New Jersey account wagering system.
12. Consider the request of the racetrack permit holders, the OTWs, the Borgata and the New Jersey account wagering system to conduct advance wagering (full or partial card) on certain designated *races* of national interest in 2021.
13. Consider the request of the racetrack permit holders, the OTWs, the Borgata and the New Jersey account wagering system to offer certain designated special *wagers* of national interest and to conduct advance wagering in 2021.
14. Consider the distribution of the Casino Simulcasting Special Fund monies (accumulated in 2019) totaling \$402,405.87.
15. Consider approval of the 2021 Backstretch Advisory Committee budget.
16. Consider the approval of the revised 2020 budget for the Standardbred Breeders and Owners Association of New Jersey.
17. Consider the request of Freehold Raceway and New Meadowlands Racetrack for a waiver of N.J.A.C. 13:71-16.5 in 2021 to allow the uncoupling of horses with common owners or trainers.
18. Consider the permit holders' request to waive the requirements of N.J.A.C. 13:74-2.4 (OTW Progress Benchmarks) for one year due to the ongoing public health emergency.
19. Consider the allocation of \$15 million in horse racing purse subsidies to the thoroughbred and standardbred industries.
20. Consider consent, pursuant to the Interstate Horseracing Act, to fixed odds wagers accepted in New Jersey on Grade 1 stakes races of national interest conducted in other states.
